Board of Directors Meeting
Minutes of October 9, 2018**

1. Call to Order: Meeting was called to order at 7:25 PM by President Bruce Kelly
2. Roll Call: Bruce Kelly, Allen Dobney, Jerry Hellinga, Chris Manley, Ric Walch and several other members.
3. Consent of the Agenda: The agenda was approved by consensus.
4. September 2018 minutes were approved on motion by Allen Dobney and second my Chris Manley.
5. Treasurer's Report: Jerry Hellinga presented the Treasurer's Report. No questions, unanimously approved on motion by Chris Manley and second by Allen Dobney.
6. Committee Reports:
 - a. Medco 4: Jerry Hellinga No update.
 - b. CB&Q: May redoing caboos starting this Thursday. She wanted to know if we wanted to stick with same point or epoxy, which is guaranteed at least 15 years.
